



**Assumption of the Risk and Waiver of Liability**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread primarily from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Nassau Racquet and Tennis Club (NRTC) has put in place preventative measures to reduce the spread of COVID-19; however, NRTC cannot guarantee that you and/or your child(ren) and/or minor(s) for whom you may act as Legal Guardian will not become infected with COVID-19. Further, attending the Club could increase your risk and/or your child(ren)'s and/or the minor(s) for whom you may act as Legal Guardian's risk of contracting COVID-19.

**Please read the following statement and acknowledge and accept same with your electronic signature:**

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), and/or minor(s) for whom I act as Legal Guardian, and I may be exposed to or infected by COVID-19 by visiting or participating in activities at the NRTC, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 while at the NRTC may result from the actions, omissions, or negligence of myself and others, including, but not limited to, NRTC employees, owners, volunteers, members, guests, visitors and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren), and/or minor(s) for whom I act as Legal Guardian, or me (including but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expenses, of any kind, that I and/or my child(ren), and/or minor(s) for whom I act as Legal Guardian may experience or incur in connection with my, and/or my child(ren)'s and/or minor(s) for whom I act as Legal Guardian's presence at NRTC or participation in any NRTC programs, activities or events ("Claims"). On my behalf, and on behalf of my child(ren) and/or minor(s) for whom I act as Legal Guardian, I hereby release, covenant not to sue, discharge, and hold harmless NRTC, its employees, owners, agents and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of NRTC, its employees, owners, agents, and representatives, whether a COVID-19 infection occurs before, during or after visitation, play or participation in any program or activity at NRTC.
